## **Queen Elizabeth Annex School Needs Assessment for Out of School Services**

#### **Purpose**

The purpose of the survey was to gain an understanding of the usage and future need for Out of School Care services for the children that attend Queen Elizabeth Annex (QEA).

### Background

Out of School Care services for children that attend QEA School have been provided by: Dunbar Kids Club, Crown Street Kids Club and Queen Elizabeth Out of School Care. Of the three, ONLY Crown Street Kids Club has offered "morning care" as part of the program. This year it was estimated that 8 children were registered with Crown Street Kids Club. In March of this year the director of Crown Street Kids Club announced that their program would be closing permanently as of June 30, 2017. This will create a significant gap for Out of School Care services available to children attending QEA – particularly for morning care. In addition, there was a sense that the need for Out of School Care services is growing, in general.

Given this information a needs assessment was determined to be required to gain further information related specifically to the needs of Out of School Care for the children of QEA, to then work with service providers to explore the option of growth within the other operating programs in our neighbourhood.

#### **Process**

A Survey was created with Survey Monkey by concerned parents and distributed by email to families that currently have children attending QEA and to families of children that have been accepted to Kindergarten at QEA for 2017/2018. There currently are an estimated 85 children enrolled in grade K-3 at our school this year, which is expected to remain stable for 2018/19. The survey results were accumulated between April 27th and May 7th 2017. It consisted of multiple choice questions and space for comments.

#### **Key Results**

48 parents responded the survey, some who have more than one child at QEA.


- 30 respondents indicated that Out of School Care was something they "definitely" or "probably" need
- Respondents indicated for 2017/18 they need but DO NOT have an Out of School Care space for:
  - Both morning and after school care (n=10),
  - Morning only (n=9), and
  - Afternoon only (n=3).

There is one discrepancy in the results that should be noted. Dunbar Kids Club only has 6 allotted spaces for children attending QEA (so it is not possible that 7 are attending). However, there is an extra child that attends DKC on Pro D days with her sibling. It is also possible that more than one parent responded on behalf of the same children, which may over represent the results.

#### Conclusion

These survey findings indicate there is a need for additional Out of School Care at QEA for 2017/18.

## Q1: Do you have children at QEA that currently attend an out of school care program? (44 respondents for 55 children)


<sup>&</sup>quot;Child will be starting kindergarten in 2017, will be requiring morning and afterschool care








## Q4: When you think about Out of School Care, do you think of it as something you need or don't need? (48 respondents)



## **Comments**

"I don't want to deal with 4 separate pick ups and drops offs each day. That's ridiculously disruptive. There should be on-site care from a single provider. Use the library or the flex space!"

"Would prefer on site afterschool care at QEA for both morning and afterschool care."


"At this time, we do not use before school care consistently because of the age of our children (we feel like because they are young it can make the day quite long for them). However, one of the parents in our family goes away for work and the before school care is necessary for us so that the other parent can get to work on time. Also, as our children get older, we may feel more comfortable with them attending before school care regularly."

"This is less than ideal because my son has two separate homes and there is already so much movement. I would love to see both at the same location, but will have to settle on whatever we can get."

"I'm open, but it's not an ideal solution"

"That would extremely unfair and complicated though."

# Q8: At the present, there will only be Dunbar Kids Club and Queen Elizabeth out of School care that will be providing AFTER school care to the children at QEA. Are you willing to join a group of concerned parents to work on advocacy for more options in our neighbourhood?
